ACTIVE MEMBERSHIP

\$100/year + \$45 non-refundable background check fee at the time of membership application. Active members receive a membership ID card in addition to the standard member certificate for presentation to prospective clients.

- Must be currently practicing as a Private Investigator within the state of Idaho.
- Provide proof of at least 250 hours of verifiable work experience as a private investigator. See professional experience hour requirement discounts below.
- Pass a background check.

ASSOCIATE MEMBERSHIP

\$75/year + \$45 non-refundable background check fee at the time of membership application.

- Must be currently working in investigative, security, or related fields that do not meet the requirements for an active membership. This is not restricted to Idaho only.
- Pass a background check

AFFILIATE MEMBERSHIP

\$50/year + \$45 non-refundable background check fee at the time of membership application.

- Must be currently doing business with those in investigative, security, or related fields. This is not restricted to Idaho
- Pass a background check

STUDENT/RETIRED MEMBERSHIP

\$50/year + \$45 non-refundable background check fee at the time of membership application.

- Must be currently enrolled in school and successfully pass a background check.
- Or Retired from the private-investigation industry and successfully pass a background check.

Greetings,

Thank you for your interest in the Certified Private Investigator (CPI) certification program. The CPI Certification and designation are a way to demonstrate experience, knowledge and competency in the private investigative field. The CPI logo and designation are reserved for those who complete the certification process through the PIAI-CPI Certification Board and is a registered trademark of the Private Investigators Association of Idaho.

This certification is not intended to substitute or replace any state or local licensing requirements. Rather act in addition to an individual's commitment to their industry and provide a level of confidence and trust with the general public, especially in states and jurisdictions where licensing or certification is not required. The CPI certification is focused primarily on "private investigations." The goal of this certification is to prove one's experience and history as a private investigator, and to demonstrate the amount of time spent working as a private investigator.

The following items are to be submitted to the CPI Certification Board.

- Membership application and applicable fees
- Copy of insurance policy (Minimum \$500,000)
- Copy of private investigator license (if required in current jurisdiction)
- Copy of business license or other business documentation (if applicant owns business)
- Completed Test
- Notarized CPI agreement
- Business card

A phone interview with the CPI Certification Board will be scheduled 1-2 weeks after the application, exam, and required documents have been received.

CPI Requirements:

- Carry and maintain E&O / general liability insurance (Minimum \$500,000)
- Have a minimum 500 hours (verifiable) experience in the field of private investigations.
 Law enforcement, government, or military experience does not qualify as private investigations.
- Be 21 years or older in age
- Must be licensed as a private investigator if your state requires licensing to practice as a private investigator.
- Pass certification exam with a score of 80% or greater. See the CPI page on the PIAI website for information regarding the exam.
- Complete 30 hours of continuing education every 2 years prior to re-certification. List of acceptable continuing education will be sent with certification packet.
- Complete an oral interview administered by the certification board.
- Pass a background investigation.
- Applicants must submit 3 professional references (references must have known applicant minimum of 3 years)
- Complete the CPI application
 - Upon Certification, CPI members receive a CPI stamp on their membership ID card and a CPI certificate in addition to the standard member certificate for presentation to prospective clients. Memberships must be renewed annually.
