The Private Investigators Association of Idaho has four membership categories. Please mail or email your submission for consideration. We currently accept PayPal, Company Check, or Money Order. PIAI Memberships are renewed annually.

ACTIVE MEMBERSHIP

\$100/year + \$45 non-refundable background check fee at the time of membership application. Active members receive a membership ID card in addition to the standard member certificate for presentation to prospective clients.

Must be currently practicing as a Private Investigator within the state of Idaho.

Provide proof of at least 250 hours of verifiable work experience as a private investigator. See professional experience hour requirement discounts below.

Pass a background check.

ASSOCIATE MEMBERSHIP

\$75/year + \$45 non-refundable background check fee at the time of membership application. Must be currently working in investigative, security, or related fields that do not meet the requirements for an active membership. This is not restricted to Idaho only. Pass a background check.

AFFILIATE MEMBERSHIP

\$50/year + \$45 non-refundable background check fee at the time of membership application. Affiliated business with those in investigative, security, or related fields. Not restricted to Idaho. Pass a background check.

STUDENT/RETIRED MEMBERSHIP

\$50/year + \$45 non-refundable background check fee at the time of membership application. Must be currently enrolled in school and successfully pass a background check.

Or Retired from the private-investigation industry and successfully pass a background check.

CPI Certification Information & Requirements

The CPI Certification and designation demonstrate experience, knowledge, and competency in the private investigative field. The CPI logo and designation are reserved for those who complete the certification process through the PIAI-CPI Certification Board and is a registered trademark of the Private Investigators Association of Idaho.

This certification is not intended to substitute or replace any state or local licensing where required. Rather, act in addition to an individual's commitment to their industry and provide a level of confidence and trust with the public, especially in states and jurisdictions where licensing or certification is not required. The CPI certification is focuses primarily on "private investigations." The goal of this certification is to prove one's experience and history as a private investigator, and to demonstrate the amount of time spent working as a private investigator.

The following must be submitted to the CPI Certification Board prior to taking the CPI exam:

- Completed application and applicable fees.
- ◆ Copy of insurance policy (Minimum \$500,000)
- ◆ Copy of private investigator license (if required in current jurisdiction)
- ◆ Copy of business license or other business documentation (if applicant owns business)
- ◆ Signed CPI application agreement
- ◆ Business card and website address (if applicable)

A phone interview will be scheduled after the application and the required documents have been received. At that time, you will be provided with your exam access I.D. code

Requirements for acquiring and maintaining your CPI Certification:

- ◆ Carry and maintain E&O / general liability insurance (Minimum \$500,000)
- → Have a minimum 500 hours (verifiable) experience in the field of private investigations. Discounts: Military & Law Enforcement: 50% reduction to 250 verifiable hours of professional work experience. Private Investigation Education: 25% reduction to 375 verifiable hours of professional work experience.
- ◆ Be 21 years or older in age.
- ◆ Must be licensed as a private investigator where required by state.
- ◆ Pass certification exam with a score of 80% or greater.
- ◆ Complete 30 hours of continuing education every 2 years prior to re-certification.
- Complete an oral interview administered by the certification board.
- Pass a background investigation.
- ◆ Applicants must submit 3 professional references (references must have known applicant minimum of 3 years)
