Membership Information & Requirements

The Private Investigators Association of Idaho has three membership categories. All members in good standing are entitled to display the Private Investigators Association of Idaho logo. Members receive a Certificate of Membership and identification card with designated member category. Please complete and email your application for consideration to membership@piai.us.

The PIAI accepts PayPal, Company Check, or Money Order. PIAI Memberships are renewed annually.

_ACTIVE MEMBERSHIP

\$100/year + \$50 non-refundable background check fee at the time of membership application. An Active Membership includes individuals and business entities currently registered as a Private Investigator in the state of Idaho. Applicant must provide proof of at least 250 hours of verifiable work experience as a private investigator. Military & Law Enforcement enjoy a 50% reduction to 125 verifiable hours of professional work experience. Private Investigators enjoy a 25% reduction to 187 verifiable hours of professional work experience. Must pass a background check.

ASSOCIATE MEMBERSHIP

\$75/year + \$50 non-refundable background check fee at the time of membership application. An Associate Membership includes individuals, business entities, state associations in the private investigations field or related industry. The Associate member honors retired private investigators and individuals in support of the Private Investigation industry. This membership category is not restricted to Idaho registered businesses. Must pass a background check.

STUDENT & ENTRY MEMBERSHIP

\$50/year + \$50 non-refundable background check fee at the time of membership application. A Student & Entry Membership includes those currently enrolled in school or continuing education courses (online or onsite) or otherwise pursuing a Private Investigation career. This membership category is not restricted to Idaho registered businesses. Must pass a background check.

PIAI membership applicants: Include the following with your completed, signed application:

- Record(s) of your verifiable private investigator experience where applicable
- ♦ DBA of business (if applicant is a business owner) where applicable
- Signed and Notarized applicant agreement and applicable membership and background check fees.

PIAI Certified Private Investigator Certification Exam

PIAI Idaho Certified Private Investigator Exam incorporates select National Investigators Training Academy (NITA) training modules and the Private Investigators Association of Idaho Certification exam. Qualifications for the CPI Certified Private Investigator Exam are as follows:

- ♦ Be 21 years or older in age.
- ♦ Be an Active or Associate member in good standing in the PIAI
- ◆ Provide copy of insurance policy (Minimum \$500,000)
- ♦ Provide copy of private investigator license (if required in your current jurisdiction)
- ♦ Provide copy of business license or other business documentation (if applicant owns business)
- Provide business card and/or website address
- Provide proof of a minimum 250 hours (verifiable) experience in the field of private investigations. Military & Law Enforcement enjoy a 50% reduction to 125 verifiable hours of professional work experience. Private Investigators enjoy a 25% reduction to 187 verifiable hours of professional work experience.
- Must be licensed as a private investigator where required by the state(s) in which you operate.
- ♦ Complete an oral interview administered by the PIAI certification board.
- Pass a background investigation.
- Certification Renewal requires proof of 20 hours of continuing education prior to renewal.

Upon Certification*, Certified Private Investigators are accredited to display the CPI seal & use the post nominal letters "CPI" after your name on all business communications. In addition, the CPI will receive a certificate for presentation to prospective clients and CPI stamp on their PIAI membership ID card.

*Certification is not intended to substitute or replace any official state or local municipality licensing where currently required. Rather, the certification, in addition to an individual's commitment to the industry, provide a level of confidence and trust with the public in the state of Idaho and jurisdictions where licensing or certification is not required.

CPI Certification applicants: Include the following with your completed, signed application:

- Record(s) of your verifiable private investigator experience and proof of insurance
- DBA of business (if applicant is a business owner)
- Applicable fees
- Signed and Notarized applicant agreement (see below).
